

# AWARD NOMINATION INSTRUCTIONS

Thank you for submitting a nomination to celebrate expertise and leadership in the reduction of greenhouse gas emissions in Canada. Nominations can be submitted for individuals, organizations, or communities. The nomination should take 5-6 hours to put together (not including the Nomination Support required by peers/colleagues) and **must include the following:** 

	Estimated Time to Complete
Tell us about the nominee in 200 words or less, and why they would be a good fit to receive the Sustainability Trailblazers Award	0.25 hours
Submit a summary of the nominee's overall contribution to greenhouse gas emissions reduction throughout the last 2 years. The submission summary should be no more than eight pages long and include details about the nominee's greenhouse gas emissions reduction strategy, initiatives, and outcomes	3.0 hours
Highlight the innovative quality and impact of the nominee's contribution to greenhouse gas emissions reduction using the relevant sections in the nomination form	2.0 hours
Ask two individuals (clients, current/former staff, partners) to support your nomination by completing the Nomination Support Form. This can be included with the nomination application or e-mailed separately before the nomination deadline	1.0 hour
Submit the nominee's biography and headshot (individual) or logo (organization or community)	0.25 hours

# AWARD NOMINATION TERMS AND CONDITIONS

#### **NOMINATION RULES:**

- 1. The nominee is not submitting the same project/initiative in any other ECO Impact Award category.
- 2. The nominee's project/initiative was not submitted in a previous year.
- 3. The project/initiative must have been conducted/completed within the last two years.
- 4. A minimum of two letters of support (from clients, employees, partners, etc.) are required for each nominee
- 5. ECO Impact 2026 sponsors are not eligible for the Sustainability Trailblazers Award.
- 6. ECO Impact 2026 speakers are not eligible for the Sustainability Trailblazers Award.
- 7. Each nomination must summarize how the nominee meets the award criteria and should be no more than eight (8) pages long. Specific project/initiative details are required.
- 8. If preferred, nominations with all the required elements can be submitted in a single .docx or .pdf file instead of the application form provided.

# In your submission, please also remember to include:

- A completed nomination form including anecdotal comments on each of the criteria
- Summary/description of project/initiative not exceeding the 8-page limit
- Headshot and bio for individual nominees
- Logo and bio for nominated organizations and communities

#### **NOMINATION TIPS:**

For a strong submission, be sure to complete all responses thoughtfully and completely. Highlight the nominee's unique contributions to greenhouse gas emission reduction in Canada.

NOMINEE'S HEADSHOT (Individual) OR LOGO (organization or community)
Attach in submission email.
